

# Conditions for Admission to Study, Admission Procedure and Studies by Foreigners Enrolled in Study Programs Executed in Foreign Language, at the EUROAMERICAN UNIVERSITY OF WASHINGTON INC DATED APRIL 1, 2024

### Article 1 Initial Provisions

Admission to study, admission procedure and studies by foreigners enrolled in study programs executed in foreign or english language at the EuroAmerican University of Washington (hereinafter referred to only as "EAUW") and their faculties (hereinafter referred to only as "foreign students") are subject to the Act on Universities and Colleges as well as the internal regulations of EAUW with the exception of the provisions contained herein.

## Article 2 Admission to Study

- (1) EAUW and its faculties admit foreign students with completed secondary or completed secondary vocational education at the equivalent level to a secondary school and with the necessary capabilities, for studies in Bachelor, Master, Doctoral and Post-graduate programs executed in foreign or English language. Furthermore EAUW faculties accept for the Master's study programs executed in foreign or English language foreign students, who have completed the Bachelor's study program in a similar study program at a university of an equivalent level to a university in the US and prove their necessary capabilities. This preamble need not apply if it concerns students from developing countries, who will put their acquired education into practice in their home country.
- (2) EAUW and its faculties accept for the Doctoral study programs executed in foreign or English language foreign students, who have duly completed the Master's study program, or possibly have duly completed university study at an equivalent level to a university in the US (M.Sc., M.A.) in the given or relating field of study and prove their necessary capabilities.
- (3) EAUW checks the necessary capabilities within other conditions for admission to study in relation to certain knowledge, abilities and results in a secondary school, or possibly higher vocational school or university, including a health certificate confirming the capability to study at EAUW.
- (4) The Dean may waive the entrance examination or a part thereof on the basis of study results and the level of the completed school.

### Article 3 Admission Procedure

(1) The admission procedure is to be commenced by delivering a written application for study to EAUW or its faculty, which executes the relevant study program in foreign or English language for foreign students:

(2) A foreign student shall pay the fee connected with the admission procedure at the amount of USD 250.

#### Article 4 Enrolment

- (1) A foreign student submits for enrolment:
  - a) a document substantiating a long-term or permanent residence permit in the US or existence of a student visa,
  - b) a certificate of concluded health and accident insurance, valid in the US for the relevant academic year,
  - c) a health certificate co,
  - d) proof of paying for the study or the existence of a contract of the obtained grant, from which the study is paid for.
- (2) The document and certificate subject to Sub-section 1 shall be understood as the original or an officially verified copy. In specific cases EAUW may also accept a non-officially verified copy.
- (3) Within 20 calendar days from the enrolment a foreign student shall be bound to conclude a contract of study in the relevant study program with EAUW and make a payment for this study to the EAUW account.
- (4) Item 3 of Article 4 shall not apply for students, who obtained their grant from EAUW or third parties and entities.
- (5) Article 5/1 is requiered only for the reguslar students not for the e-learning online.

# Article 5 Fee for the Study in Foreign Language

- (1) The amount of the fee for study in foreign language is based on the real average costs per student studying in the relevant type of a study program at EAUW.
- (2) For the next academic year, EAUW publishes the amount of the fee for the study in foreign language no later than two months prior to the application submission deadline.
- (3) The fee paid for the study in foreign language shall not be returned in the case of ending the studies for the following reasons:
  - a) failure to meet the requirements arising from the study program in compliance with the Study and Examination Rules,
  - b) expulsion from the study pursuant to Section 65, Sub-section 1 c) or Section 67 of the Act.
- (4) The fee paid for the study in foreign language shall be partially returned in the case of ending the studies for the following reasons:
  - a) finishing the studies due to serious health reasons on the basis of a medical report,
  - b) withdrawal of the accreditation in relation to the study program,
  - c) extinction of the accreditation in relation to the study program.
  - In cases listed under a) to c), EAUW shall return a part of the fee for the study in foreign language after deducting the already spent expenses.
- (5) The fee for the study in foreign language shall be payable within 20 calendar days after the enrolment, while the day of payment shall be considered to be the date on which the EAUW account is credited with the relevant sum.
- (6) The Rector or Pro-rector for foreign affairs, appointed by him, may decide on payment of the fee for the study in foreign language to be made in instalments on the basis of a written request by a foreign student.

#### Article 6 **Joint Provisions**

- (1) A foreign student shall be bound to comply with the contract of study specified in Article 4, Sub-section 3. Failure to comply with the obligations arising from this contract shall be usually considered to be a disciplinary offence.
- (2) EAUW shall issue a foreign student who has duly completed the study with the relevant diploma according to the achieved education in English language.
- (3) On the basis of the written application submitted by of a foreign student, EAUW shall arrange his/her accommodation in a student hostel. A foreign student shall be accommodated at his own expense and is bound to observe the hostel rules and instructions of the hostel administrator; failure to comply with these may result in expulsion from the hostel. In such a case EAUW shall not be obliged to arrange alternative accommodation for the foreign student.
- (4) At the request of the foreign student, the faculty providing the relevant study program shall issue confirmation of the study stating the type of the study and the information that it concerns a foreigner self-payer.

#### Article 7 **Final Provisions**
